The candidate must possess a desire to be a part of a special team to capture hearts, elevate character and intellect, and prepare our students to thrive in life. **Preferred candidates will contribute to the academic and extracurricular life of the school through a willingness to coach and/or sponsor a club.** Salary is commensurate with education and experience. ### Responsibilities

- Create lesson plans based on appropriate safe, effective, progressive, and functional resistance training regarding long term development and present fitness level.
- Work in cooperation with and communicate often and effectively with the Sports Medicine Director, Sports Fitness Center Director, and coaches in regards to needs of sport fitness development, seasonal adjustments, and individual fitness.
- Design and implement testing and measurement of student training.
- Keep the Sports Fitness Center neat, clean, and a source of pride.

- Successfully completes training and educational courses as required.
- Coach two seasons

## **Requirements & Qualifications**

- Bachelor's Degree in Exercise Science, Kinesiology, Human Performance, or similar required.
- Professional certification preferred through NSCA or USTFCCCA.
- Current CPR/AED certification or willingness to immediately obtain.
- Strong working knowledge and teaching skills and methodology of instruction in analysis, techniques, and measurement of biomotor abilities (strength, speed, stamina, mobility, coordination).
- Definitive experience and/or expertise in sport and fitness programming for high school populations.
- Distinct motivational ability.
- Ability to interact positively and effectively with students, staff, and parents.
- Distinguished organizational skills and productive oral and written skills.
- Add prominent value to the program.

## **Standard Physical Requirements:**

- Must be able to sit and/or stand for an extended period of time.
- Must be able to bend, reach, lift and climb.
- Must be able to constantly operate a computer, and other office machinery, such as calculator, copy machine, computer printer.
- Must be able to understand written and verbal instructions.
- Must be able to communicate and respond to questions from various levels with the organization.
- Must have manual dexterity sufficient to perform specified duties.
